## ORDER

Government sanction the employment of a Special Officer and Staff as specified below, for a period of one year, from the date of appointment for work connected with the Survey of encroachments in the Cardamom Reserve in the Taluks of Devicolam, Udumbanchola and Peermade in the Kottayam District:-

# FIELD STAFF

- (1) One Special Officer (Survey and Settlement Officer ) on Rs.350-600 per mensum.
- (2) Three Head Surveyors on Rs.125-225 per men sum each..
- (3) Eighteen Surveyors on Rs.50-150 per men sum each.
- (4) Thirty-nine chairmen on Rs.30-40 per men sum each.

  The posts of chairmen sanctioned above should be created in the regular establishment and not on the out-turn wages system.

### Office staff for the special officer.

- (1) Four Draftsmen, Second Grade, on Rs.50-150 per men sum.
- (2) One Peon on Rs.30-40 per men sum.

# Special staff for the Central Survey office, Trivandrum.

- (1) One Draftsmen, First Grade, on Rs.80-180 per men sum.
- (2) Seven Draftsmen, Second Grade, on Rs.50-150 per men sum each.
- (3) One Binder on Rs.40-80 per mensum.

The above staff for the Central Survey Office, Trivandrum should be appointed only after six months from the date of appointment of the field staff.

- 2. The expenditure on account of the entire staff should be debited to "7 Land Revenue (b) Survey, Settlement and Records operations" in the current years' budget.
- 3. The technical staff for the posts sanctioned in paragraph 1 above, will be deputed by the Director of Survey and Land Records from the Survey Department.

- 4. The Survey of encroachments in the estates in the Peer made taluk ordered in G.O.Rt.No.1143/Rev. dated 12-9-'58 should be stopped when the survey of encroachments in Cardamom Reserve is taken up and the personnel engaged in that work diverted for the new work.
- 5. Udumbanchola will be the headquarters of the Special Officer and staff and the District Collector, Kottayam will have administrative control over their work.
- 6. The Special Officer will submit proposals to Government for the additional staff, if any, that may be required by him.
