<u>ORDER</u>

Government have directed in Memorandum 20675/FE4/63/AD dated 3—8—1964 that the question of evicting the occupants of the entire Peechi Project area (both from the Peechi Project area and the and the Peechi Game /sanctuary area falling outside the Project area) should be taken up and completed simultaneously. The District Collector, Trichur in his report No.D3-20963/64 dated 15-10-1964 to the Board of Revenue has stated that the occupations in areas outside the Peechi Project have also to be evicted and hence the enumeration work has to be taken up a fresh. It is reported that there are various types of occupations numbering about 300 and the District Collector has suggested that the employment of a special staff consisting of a Special Deputy Tahasildar, 4 Village Assistants and a Peon for a period of a3 months is necessary for listing out the occupations. The Secretary, Board of Revenue has endorsed the recommendation of the Collector.

2. In the circumstances, sanction is accorded for the creation of the posts of one special Deputy Tahsildar on Rs.150-250, 4 Village Assistants on Rs.40-100 and a Peon on 30-40 for a period of three months from the date of appointment for enumeration of occupations, of the Peechi area.

3. The expenditure will be debited to the Head of Accounts 70 \odot (iv) C. in the Budget for 1965-66. Additional funds, if found necessary under the Head will be provided by reappropriation.
