## ORDER

In the Government Order read above it was ordered that a lease rent of Rs.475/-(Rupees Four Hundred and Seventy Five only) per hectare per annum will be realized from the Kerala State Electricity Board and other Government owned commercial undertakings for forest lands leased out to them for project purposes from 18-12-1978 and that this rate would prevail for three years with effect from 18-12-1978. The period has expired on 17-12-1981.

The Chief Conservator of Forests in his letter read as second paper has submitted proposals for the revision of rate of lease rent with effect from 18-12-1981 for a period of three year. Government having considered the proposal order that lease rent at the rate of Rs.615/- (Rupees Six Hundred and Fifteen only) per hectare per annum will be realized from the Kerala State Electricity Board and other Commercial undertakings for the forest lands lease out to them for project purposes and for plantations. The above rate will prevail for three years with affect from 18-12-1981 to 17-12-1984.
