ORDER

In the Government Order 3rd read, certain officers were exempted from the total prohibition in the use of Government vehicles for non-duty purposes imposed in the Government Order 2nd read. Non-duty usage of Government vehicles to those categories of officers is allowed on payment of hire charge at 75 paise per k.m. Government have now decided to revise this rate of hire charges. Rule 25 of the Rules for the use of Government Motor Vehicles issued in Government Order read as first paper above as amended in G.O. (P) 307/76/Fin. Dated 29-9-1976 as such is hereby amended with effect from the date of the order, as follows:

Rule 25, Substitute the following for the existing rule:-

“When Government Motor Vehicles are used for non-duty journeys the fare livable will be at the following rate:-

Motor Cabs with a seating capacity of not more than 7 persons including driver	- Rs.1.25 per k.m.
