ORDER

The Secretary, Board of Revenue (L.R.), Trivandrum in his letter read above has brought to the notice of Government an instance where a Special Tahsildar had drawn a large sum in excess of the budget provision in April 1984 under "Travel Expenses" before the allotment for the year 1984-85 was received. The explanation given by the Tahsildar for the irregular drawal of funds was that in para I (vii) of the G.O read as first paper above incorporated as Appendix-II of the Kerala Budget Manual, no limit is imposed on the payment that can be made in April of a year. In order to prevent the misuse of the above provision, the Secretary, Board of Revenue (L.R.) has requested Government to impose a suitable limit upto which amounts can be drawn in April, before the distribution of the Budget provision by the Chief Controlling Officer is given.

- 2. Government after examining the proposal are pleased to order that the treasuries will make payments during the month of April, subject to the condition that the amount so paid should not exceed 1/12 of the previous year's allotment pending receipt of allotment orders.
- 3. Necessary amendment to Appendix-II of the Kerala Budget Manual will be issued separately.
