## **ORDER**

Government are pleased to order that the various Authority measures ordered in G.O.(P)769/87/Fin. Dated 18.9.1987 will continue to be enforce until further orders.

- 2. The following additional measures are also ordered with immediate effect.
- (i) The budget provision under "Office Expenses" and "Travel Expenses" should not be allowed to be exceeded on the grounds of increase in Postal, Telephones, Petrol, Oil and Lubricants and Railway rates and other increases in costs.
- (ii) Now fixtures and furnishings should not be purchased solely because of change in incumbents.
- (iii) In view of the increase in cost of fuel the use of Departmental vehicles should be regulated to conserve fuel and also the life of the vehicles.
- (iv) Engagement of casual labour should be discouraged to the maximum extent possible.
- (v) The existing orders on creation of additional posts should be strictly adhered to
- (vi) All instructions regarding reappropriation of funds should be strictly followed during this year.
- (vii) Maintenance of buildings and other installations may be under-taken in unavoidable circumstances only.
- (viii) All Heads of departments should carefully monitor the receipts which have been budgeted for 1988-89 and ensure that defaults do not take place.

3. The above instructions are applicable to all Departments including the Science and Technology Department, all public undertakings, Boards/Corporation and Local Bodies.
