As per Government Order read as (1) above orders were issued to enhance the financial powers of the Departmental Working Group for according administrative sanction from ₹ 1 crore to ₹ 3 crore. It was also ordered to constitute a Special Working Group for considering proposals on issue of administrative sanction for new plan schemes with outlays exceeding ₹ 3 crore.

2. The meeting of the Chief Secretary with Secretaries held on 17.12.2011 has recommended to consider enhancing the limit of financial power of Departmental Working Group from ₹ 3 crore to ₹ 5 crore so that the Special Working Group can look into proposals exceeding ₹ 5 crore only from 2012-13 onwards.

3. Government have examined the matter in detail and are pleased to approve the recommendations. Accordingly, Government order that the financial power of the Departmental Working Groups for according administrative sanction for plan schemes, stands enhanced from the existing financial limit of ₹ 3 crore to ₹ 5 crore with effect from the financial year 2012-13. The Special Working Group will consider only those proposals, of administrative sanctions for plan schemes with outlays exceeding ₹ 5 crore.

It is also ordered that the Departmental Working Groups and the Special Working Group shall hold meetings at least once in a month from April 2012 onwards.

4. The Government Order read as (1) above stands modified to the above extend.


