## CIRCULAR

Sub:—Deputation of State Government Officers to foreign service— Further instructions—Issued.

Ref:-1. Circular No. 86/90/Fin. dated 28-12-1990.

2. Letter No.PC.1/Genl./29/203 dated 30-4-1992 from the Accountant General (A & E), Kerala, Thiruvananthapuram.

In the circular cited, Government had instructed that the scale of pay of the officer ordered to be sent on foreign service should be furnished invariably in the Government Orders sanctioning the deputation. But this is not being followed by the various departments of Government. As a result the Accountant General has to call for the details relating to the non-gazetted officers every time when an officer is deputed to foreign service, causing unnecessary delay in intimating the rate of pension contribution and leave salary contribution to the foreign employer.

1/3/2. Government hereby again instruct that the scale of pay of the officer deputed shall be furnished in the Government order granting deputation without fail.

3. In future, when deputations are made to Government owned or controlled undertakings it shall be mentioned in the Government order itself that no leave salary contribution is payable in terms of Note below Rule 146, Part I, Kerala Service Rules.

4. All the terms and conditions of deputation shall also be invariably specified in the Appendix to the Government orders sanctioning the deputation.
