

PENSION—SETTLEMENT OF GLAIMS IN RESPECT OF MAN MISSING CASES-FURTHER MODIFICATION—ORDERS ISSUED

## ORDER

In the G.O. read above, orders have been issued to sanction family pension to the family of a missing pensioner/serving employee, one year after he is reported missing and that the period of one year is to be reckoned from the date on which F.I.R. is lodged with the police authorities.

- 2. In the Office Memorandum read as second paper above, Government of India have issued orders that family pension should be sanctioned from the date of lodging F.I.R. or expiry of leave of the employee, whichever
- 3. Since such a provision is not made in the State, Government have examined the matter in detail and are pleased to modify orders as below:
- 4. Family pension in pursuance of the Government Order read above will continue to be sanctioned and paid one year after the date of lodging the F.I.R. but it will accrue from the date of lodging the F.I.R. or expiry of leave of the employee who has disappeared, whichever is later. In such cases when sanction for family pension is issued, the payment of pension from the

date of accrual may be authorised. While sanctioning payment of femily pension, it will be ensured by the concerned authorities that Family assion is not authorised for any period during which payment of pay and allowances in respect of the disappeared employee was made.
