ORDER

As per G. Os. read as 1st and 2nd papers above, orders were issued in setling pensionary claims in man missing cases on the analogy of the orders in Central Government. The benefit contemplated in the above orders is applicable to regular employees only and its applicability to the part-time contingent employees in the State has not been specifically mentioned therein. Part-time contingent employees were sanctioned pension with effect from 1-7-1988 and Family Pension to their families with effect from 3-9-1997 onwards as per the G. Os. read as 3rd and 4th paper above.

2. Government have received representations from the families/heirs of part-time contingent employees in man missing cases to sanction family pension.

3. In the circumstances, Government have examined the matter in detail and are pleased to order that the benefit of G. Os. read as 1st and 2nd will be extended to the families of part-time contingent employees/pensioners also in man missing cases with effect from 3-9-1997. The benefit of these orders will be made applicable in the man missing cases prior to 3-9-1997 also with effect from 3-9-1997.
