ORDER

As per letter read as 1st paper above, the Additional Principal Chief Conservator of Forests (Dev) has furnished Annual Action Plan for utilization of financial assistance under 13th Finance Commission Award 2013-14 along with the proposal for revalidation of unspent balance under the scheme for 2012-13 for utilization in current financial year.

- 2. The State Level Empowered Committee Meeting on 13th Finance Commission Award in their meeting held on 08.07.2013 approved the Action Plan submitted by the Additional Principal Chief Conservator of Forests (Dev) for implementation during 2013-14.
- 3. In the circumstances, Government are pleased to accord Administrative Sanction for the implementation of the Annual Action Plan appended to this order for utilizing of financial assistance under 13th Finance Commission Award 2013-14 at an estimated cost of Rs.3388 lakh (Rupees Thirty Three Crore Eighty Eight lakhs only).

4. The expenditure on this amount may be debited under the Head of Account 2406-01-101-84 - Schemes under 13th Finance Commission Recommendations under 13th Finance Commission Award under Plan & Non Plan accordingly to the nature of expenditure.

5. In the case of purchase / procurement where estimated cost of purchase is more than the powers delegated to Principal Chief Conservator of Forests (Group I Head of Departments) who purchase stores for Rs.25 lakhs or more in a year (3 lakhs at a time, Rule 97 Store Purchase Manual) the proposal shall be placed before the Departmental Purchase Committee for its recommendation for issue of purchase sanction in accordance with the provisions contained in Stores Purchase Manual.

6. The Principal Chief Conservator of Forests & Head of Forest Forces and the officials of Kerala Forest Department shall ensure that the financial assistances under 13th Finance Commission Award are being utilized strictly in accordance with the conditions specified in all the Government Orders issued in this regard and as per the provisions of relevant Manuals and Codes.
