As per the Government Order 3rd read above, a modified Family Benefit Scheme was introduced with effect from 1-4-1998, enhancing the rate of subscription.

It has come to the notice of Government that certain Drawing and Disbursing Officers are deducting subscription at enhanced/revised rates without obtaining revised option at enhanced rates, which is irregular and not admissible as per rules.

In such cases, eventhough recovery is effected at enhanced rate, the employees are not entitled to receive the benefits under the enhanced/revised scheme. This causes undue hardships to the legal heirs of the subscribers who die in harness.

In order to mitigate the hardship caused to the legal heirs of the deceased subscribers, all Drawing and Disbursing Officers are hereby instructed to ensure that revised option from the subscribers, who opt to the enhanced/revised scheme are obtained before deduction from their salary is effected as laid down in the Government Order read as 2nd and 3rd paper above. In the case of existing subscribers who opt to change over to the revised rates, the arrear from 1-4-1998 should also be recovered from their salary in equal instalments.
