Government as per the statutory provisions contained in Rule 22 A part I Kerala Service Rules Rule 3(1) of SLI Rules have issued detailed instructions regarding compulsory enrolment of all eligible employees who have entered in Government Service on or after 19.8.1976, in the SLI Scheme and to subscribe the rate of premium as per the pay range fixed from time to time. Instances have come to the notice of Government that some employees as well as Drawing and Disbursing Officers are not paying adequate attention for the effective implementation of the SLI Scheme and even recommending proposals to exempt the employees from joining the scheme on flimsy grounds.

2. Government have reiterated the necessity for compulsory enrolment in the scheme in several occasions and even clarified that those employees who have insured with the LIC of India and other Insurance Schemes prior to their entry into Government Service ~~xx~~ shall be the subscriber to the SLI Scheme, in spite of all these instructions issued by Government from time to time, it is noticed that so many employees in various Departments are yet to be enrolled in the scheme.

3. In order to ensure that all eligible employees are admitted to the SLI scheme, Government decide to gather information from all Departments about the present enrolment positions in the format appended along with this Circular. All Heads of Departments and Drawing and Disbursing Officers are directed to furnish the details of enrolment of employees in the SLI scheme in the prescribed pro forma to the Director of Insurance, Thiruvananthapuram on or before 31.3.1999, under intimation to Government. Any laxity noticed on the part of the Drawing and Disbursing Officers will be viewed seriously and action initiated against them.
