ORDER

In the G.O. read first above employees who entered in to service before 1-9-1984 were permitted to join the Group Insurance Scheme subject to the condition that the first instalment of subscription at full rate should be deducted from the salary of September 1995 to be cashed in the month of October 1995.

- 2. Later, in G.O. read second above the time to join the Scheme was extended from September 1995 to March 1996 subject to the condition that the first instalment of subscription at full rate should be deducted from the salary of March to be cashed in April 1996.
- 3. In the letter third cited the Director of Insurance has reported that there are instances where deductions have been made from the salary of October, November, December 1995 and January on the presumption that they also will be enrolled/admitted to the Scheme. Therefore a clarification to the G.O. cited 2nd appears to be necessary in this regard.

Government, after examining the facts in detail, are pleased to order that as per G.O. 2nd cited, membership to Group Insurance Scheme will be given to those employees who joined service before 1-9-1994, where first instalment of subscription has been deducted from the salary for the months of September 1995, October 1995, November 1995, December 1995, January 1996, February 1996 or March 1996 cashed in April 1996.
