ORDER

The Kerala Forest Department is implementing World Bank Aided Kerala Forestry Project. This is a time stipulated project to be implemented within a period of four years commencing from 1998-99. The Principal Chief Conservator of Forests(G1) in his letter read above has requested the Government to enhance financial powers to the officers of the Forest Department under the World Bank aided Kerala Forestry Project since the existing delegation of financial powers is not sufficient for the timely and effective execution of Kerala Forest activities in respect of certain items related to the project such as procurement of stores and stationery articles, civil works, conduct of seminars/workshops, training etc.. Further to that there are some new activities in the project for which presently there is absolutely no delegation to the Chief Conservator of Forest or Principal Chief Conservator of Forest as these are not the normal activities of the Department. These activities mainly relate to HRD consultancies, studies etc. for which special delegation is necessary for the departmental officers. The empowered committee constituted for this purpose met on 6.4.98 and recommended the proposal.

2. Government after examining the recommendation in detail, order that the financial powers of the Principal Chief
