## ORDER

The National Forest Policy envisages people's involvement in protection and development of forests as the people living in and around forests could be motivated to involve themselves in the protection and development of forests and at the same time they can be allowed to enjoy certain benefits regarding collection of firewood, fodder, thatching grass etc. Government of India have also issued policy guidelines for peoples participation in the management of Forests. These guidelines indicate the responsibilities of the people living in and around the forests as well as the benefits to be extended to them.

As a Government Order read above Government have accorded administrative sanction for the implementation of the World Bank aided Kerala Forestry Project during 1997 - 2000. Joint Forest Management Programme was examined by the World Bank Consultants and in the AID MEMOIRE issued after discussion with the representatives of the World Bank the participatory forest management programme was agreed to as as essential ingredient of the Scheme.

In the light of the recommendation of the Principal Chief Conservator of Forests in his letter read above, Government are pleased to accord sanction for the Joint Forest Managment System for the protection and development of the forests.

- (a) IN THE ARMA OF DRY DECIDUOUS FORESTS OF ATTAPPADY.
- (b) IN THE AREAS WHERE SETTLEMENT EXISTS WITHIN THE FORESTS.
- (c) A FEW PILOT CASES IN THE NORMAL FOREST FRINGE AREAS.

For these three specified models in all nine plots may be selected, two plots for (a), three plots for (b) and four plots for (c).

### Model (a):

The two places suggested for the Dry-deciduous forests of Attappady shall be located in Munnarghat Forest Division - under whose jurisdiction the Dry-deciduous forests of Attappady are situated.

### Model (b):

The three plots suggested under(b) shall be located in Paruthipally Range of Thiruvananthapuram Division, Thodupuzha Range of Kothamangalam Sivisions and Kannoth Range of Kannur Division.

Model(c):

The four plots suggested under this model shall be selected in Anchal Range of Punclur Division, Frumeli Range of Kottayam Division, Peechi Range of Thrissur Division and Edavana Range of Nilambur North Division.

The plots shall be selected by the concerned Divisional Forest Officer and approved by the Conservator of Forests.

The extent of the plots shall be roughly 100(hundred) Ha.

#### Forwation of Committee:

A committee comprising the following composition shall be constituted for the study and evolution of suitable models

- (a) Divisional Forest Officer Ex-Officio Chairman.
- (b) Range Officer Ex-Officio Secretary.
- (c) Ten members from the people living in and around the plots. These members will be thosen by the Divisional Perest Officer in consultation with the concerned Panchayat President and MLA the people actually involved in the programme.
- (d) Village Extension Off.cer Ex-Officio member.
- (e) In Tribal areas the Tribal) Ex-Officio member.

(f). One representative from N.G.O. as nominated by the Chairman.

# Quorum of the Committee:

One third the members of the committee shall constitute The meeting shall be convened by the Secretary. the quorum.

# Functions of the Committee:

- The committee shall study the status of the Forests, (a) causes for degradation, activities required to restore the original status of the Forests etc.
- The extent of pressure on the Forest wealth in the plot, this should be quantitified in detail indicating (b) the details of families enjoying the different benefits
- Measures necessary to reduce/eliminate the pressure on the Forest wealth of the plot and at the same time (c) suggestions for meeting the needs of the people involved to the extend, hitherto they were enjoying.
- The committee shall finalise the study and frame the report within three months of its constitution. (d)

As far as possible, the committee shall meet as close to the plots so that the information gathered could be physically verified by them if found necessary. :

As allowance of %.50/- per meeting shall be paid to the non-official members. The expenditure on this account will be met from the contingencies.
