As per the letter read 1st paper above, Government of India issued General approval under Section 2 of the Forest (Conservation) Act 1980 for the diversion of forest land to Government Departments on specific conditions.

- 2. The Chief Conservator of Forests (Special Afforestation) & Nodal Officer, Thiruvananthapuram as per letters read 2nd paper above has forwarded a proposal for the diversion of of 0.0479 ha of forest land under Section 2 of Forest (Conservation) Act, 1980 for the construction of weir across river Kallar at Kadavupuzha in Malayalappuzha Grama Panchayath. The Kerala Water Authority is the User Agency.
- 3. Government have examined the matter in detail and are pleased to accord sanction for the diversion of of 0.0479 ha of forest land under Section 2 Forest (Conservation) Act, 1980 for construction of weir across river Kallar at Kadavupuzha in Malayalappuzha Grama Panchayath in favour of Kerala Water Authority (User Agency) subject to the following conditions:
 - 1. The legal status of the forest land shall remain unchanged.
 - 2. The forest land shall be used for the subject purpose only.
 - 3. Construction should not involve felling of trees.
 - 4. The land will be resumed to the Forest Department after the purpose is served.

- 5. The User Agency shall not use the forest land for any other purpose other than the purpose for which the forest land is diverted.
- 6. The Net present Value of the forest land should be remitted to Adhoc CAMPA account in CAF Kerala CA 1586 in the Corporation Bank, Block II, CGO Complex, Lodhi Road, New Delhi and reported to Government of India and State Government.
- 7. An undertaking to pay any additional Net Present Value as and when requested by the Forest Department shall be furnished by the User Agency.
- 8. The User Agency shall abide by other conditions, if any, imposed later on by the Government of Kerala/Forest Department, in the interest of forest conservation.
- 9. The User Agency shall be responsible for any loss to the flora and fauna in the surroundings and shall take all possible measures to conserve the same.
