ORDER

In the Government orders read as 1st 2nd and 3rd papers above, Government have sanctioned certain allowances/amenities to the police Personnel. These benefits, with slight modifications, were extended to corresponding categories in the Fire Force, Prison Forests, Excise and Vigilance Departments as per the Government Orders read as 4th to 8th papers above. ‘Special Allowance’ is one of the items of allowance sanctioned to these categories. In the Government order read as ninth paper above it has been ordered that the special allowance sanctioned to the police personnel and corresponding categories in the Fire Force, Prison Forest Excise & Vigilance departments will be classified as ‘compensatory allowance’ under Class VI Appendix IV Kerala Service Rules and the personnel on deputation to other departments, Public Sector undertakings etc, will not be to the Special allowance. It has also been ordered in the said Government order that the ‘Special Allowance’ will be admissible during periods of leaves.

2. In this letter read as tenth paper above, the Accountant General has sought clarifications to whether the “Special Allowance” is payable during periods of all kinds of leave with allowances irrespective of the duration of the leaves.

3. Government have examined the point in detail and are pleased clarify that the ‘Special Allowance is payable during periods of all kinds of leaves with allowances, but the drawl of this compensatory allowance during periods of leave shall be restricted to four months as in the case of House Rent Allowance.
