**ORDER**

In the Government Order read as 1<sup>st</sup> paper above it was ordered that the period treated as ‘dies-non’ under rule 14A Part I, Kerala Service Rules would not count for probation and that it would take effect from 7-1-1984. It was also ordered therein that all cases in which a period treated as ‘dies-non’ under rule 14A, Part I, Kerala Service Rules had been counted for probation on or after 7-1-1984, would be re-opened and revised orders issued by competent authorities in accordance with these orders and that amendments to the relevant Statutory Rules would be issued separately. Government had subsequently decided not to go ahead with the proposal to amend the relevant rule in Kerala Service Rules and Kerala State and Subordinated Service Rules.

As per the Government Order read as third paper above issued in pursuance to the Government Order 2<sup>nd</sup> cited, rules 14A, 55A, 60A etc., of the Kerala Service Rules have been deleted with effect from 3-2-1988 and therefore the orders issued in the Government Order read as 1<sup>st</sup> paper above have become in fructuous with effect from 3-2-1988. Since the orders withdrawing ‘dies non’ and other related provisions have effect only from 3-2-1988, the cases arising between the period from 7-1-1984 [viz, the date of effect of G.O. (Ms) 325/84/GAD. Dated 12-9-1984] to 2-2-1988 will have to be governed by the Government Order read as 1<sup>st</sup> paper above, so long as it is not cancelled.

Government after examining the matter in great detail are therefore pleased to order the cancellation of the Government Order read as 1<sup>st</sup> paper.
