Clause 24 of the agreement for the above work as it stands now enable Govt. to realise penalty only on average basis for uncleared area. In order to make the Contractor liable to pay fine for both non-clearance and non removal of felled trees the above clause has to be amended. The following amendment proposedby the Chief Conservator of Forests is approved.

"The contractor shall complete the work provided for herein including removal of all the stock from the contract area on or before Under very special circumstances for good and sufficient reasons the Govt. may grant extension of time on realisation of penalty or penalties noted below for completion of each work for each month.

Penalty will be assessed and realised on timber firewood, bamboos and charcoal as the case may be, which are left either uncollected or unremoved during the original contract period in addition to the penalty assessed on area basis. In the event of the contractor failing to remove the stock from the contract area by the expiry of the extended period such stock shall be forfeited and shall revert to the become the absolute property of the Government and the contractor shall not by reason of such forfeiture be entitled to any refund or abatement of the amount payable or due from him this contract".
