## **ORDER**

As per Rule 90 (6) Part III Kerala Service Rules, eligibility of family members for Family Pension has been laid down. In the G. O. 2nd cited the definition of family for the above purpose has been revised. But the said rule and the order as such are not applicable in the case of part-time employees/ pensioners. In the G. O. read as 1st paper above, Family Pension is admissible to dependents of part-time contingent employees/pensioners on the event of their death. Now clarification is sought by certain Departments whether Family Pension is admissible to parents of deceased part-time employees also as admissible in the case of regular employees/pensioners.

Government have examined the matter in detail and are pleased to accord sanction for the payment of Family Pension to the legal heirs of deceased Parttime Government employee/pensioner also as per the definition of Family laid done in Rule 90 (6) of Part III KSRs and the Government Order 2nd cited.

This order will be applicable in the cases of Family Pension which remain unsettled and in new cases.
