S. R. O. No. 190/2002.—In exercise of the powers conferred by sub-section (1) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:—

RULES

(C. S. No. 2/2002)

- 1. Short title and commencement.—(1) These rules may be called the Kerala Service (Amendment) Rules, 2002.
- (2) They shall be deemed to have come into force on the 5th day of January 1999.
- 2. Amendment of the rules.—In the Kerala Service Rules in Part I in Appendix VII in Section II, in Rule 3, after sub rule (g) the following shall be inserted namely:—

33/778/2002/DTP.

"(h) Government officials who are office bearers of District Sports Associations and District Sports Councils shall be granted Special Casual Leave not exceeding 10 days for attending meetings of District Sports Associations and District Sports Councils".
