It has been ordered in Paragraphs 1(ii) and (iii) of the G.O.read as fourth paper above, that the entire work establishment service/contingency service rendered in whole-time posts in the case of those who were absorbed into or appointed on the advice of the Public Service Commission to regular establishment from work establishment/contingent establishment will also be counted for the grant advance increments in the fixation of pay in the revised scales.

Government are now pleased to further clarify that in the case of work establishment or contingent employees full-time contingency service proceeding work establishment service or work establishment service (full-time) proceeding contingency service as the case may be and any one of those two kinds of service interposed between spells of the other will also be counted for advance increments.
