O R D E R

As per the G.O. read as first paper above, sanction was accorded for the diversion of 22.4 ha of Forest land for laying 220 Transmission line from Thrissur to Kozhikode. The Chief Conservator of Forest in the letter read as second paper above has requested Government to award a loaded contract for sale of standing tree growth in the area stipulating a condition to extract the Teak and Rosewood trees and to deliver the timber and firewood obtained therefrom to Chalakudy and Muzical depots respectively on payment of working charges.

Government have examined the request and are pleased to accept sanction to award loaded contract for sale of standing tree growth except Teak & Rosewood standing in the area subject to the condition that the purchaser should deliver Timber and Billets obtained from Teak Rosewood to Chalakudy and Muzical depots respectively for which working charges will be given at departmental rates.

The Divisional Forest Officer concerned should enlist the Teakwood and Rosewood in the area and assess the quantity of timber and billets from them before awarding loaded contract for sale of other tree growth.
