KERALA SERVICE RULES, PART II- ORDERS-ISSUED

ORDER

According to Rule 21, Kerala Service Rules, Part II, an Officer on tour may draw the lower rate of road mileage for journeys performed in public conveyance between places connected by rail or connected partly by rail and partly by road. The Government of India, in their office Memorandum No.F.5(60) E. IV (B) 64 dated 23-11-1964, have ordered that,when a journey on tour is performed by road between places connected by rail,the officer will be entiled to actual fare paid for a seat plus incidentals admissible as for journey by rail, or the lower rate of road mileage prescribed limited to rail mileage, whichever is less.

2. Rule 20, Kerala Service Rules Part II, contemplates the grant of incidental expenses for journeys by railway, subject to a minimum of daily allowance in ordinary cases and to a minimum of half daily allowance in cases where half daily allowance is claimed for arrival at or departure from an outstation under Rule 63. But according to the Supplementary Rules of the Government of India, an Officer gets only the fare of the class of accommodation plus incidentals at the rates prescribed depending on the actual distance travelled.

3. It has been decided that, in the matters mentioned above, the State Government rules should be brought in line with the rules applicable to Central Government Servants. The following amendment to the Kerala Service Rules is accordingly issued.

NOTIFICATION

In exercise of the powers conferred by the Proviso to Article 309 of the Constitution of India, the Governor of Kerala hereby makes the following amendment to the Kerala Service Rules, namely:-

AMENDMENT

(C.S. No.84/66 dated 21-2-1966)

In Part II of the said Rules,

(A) In rule 20,

- (1) for sub rule (b) and the provisos thereunder, the following shall be substituted, namely:-
 - (b) an allowance for incidental expenses calculated as follows:-
 - (i) for an officer of the First Grade 35 paise for every 10 kilometres or part thereof if it exceeds 5 kilometres:
 - (ii) for an officer of the Second Grade, 24 paise for every 10 kilometres or part thereof if it exceeds 5 kilometres:
 - (iii) for an officer of the Third Grade, 13 paise for every 10 kilometres or part thereof if it exceeds 5 kilometres.
 - (iv) for an officer of the Fourth Grade, half the third class fare by passenger train.

- (2) In the Ruling No. I, words and brackets “ i.e.one daily allowance)” shall be deleted.

(B) For rule 21, the following shall be substituted, namely:-

“ 21. Whenever road journey is performed between places connected by rail, the road mileage will be regulated as follows:-

- (a) When the journey is performed in a public conveyance,
- (i) actual fare paid for a seat in the public conveyance plus incidentals admissible as for journeys by rail, or
 - (ii) lower rate of road mileage as admissible to his class for the entire journey limited to rail mileage,
- whichever is less.
- (b) When the journey is performed by special conveyance road mileage limited to the rail mileage admissible to his class for the entire journey”.
