## ORDER

With a view to codifying the orders issued in the G. Os. read above, the following notification is hereby issued

#### NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Kerala hereby makes the following amendment to the Kerala Service Rules namely:-

# AMENDMENTS C.S.No. 155/68

In Part I of the said Rules.---

In rule 103, after clause (g), the following shall be added:-

"(h) Government Servants drawing a pay of Rs.120 or less pet mensem who serve as Home Guard volunteers".

- 1. In clause (f) the word "and" occurring at the end shall be deleted.
- 2. In clause (g) after the words 'Excise Department' the following shall be added "and"
- 3. After Note 2 the following shall be added as Note 3—

"Note-3

Hospital leave will be grated to the Officers coming under clause (h) above only in cases of injuries sustained while on duty as Home Guard volunteers and only if the application is supported by a certificate from the Commandant General. Home Guards, to the effect that the injury was sustained by the employee while on active duty as a Home Guard Volunteer. This will be in addition to the certificate prescribed in Note above".
