No. – In exercise of the powers conferred by section 17 of the Kerala Private Forests (Vesting and Assignment) Act, 1971 (26 of 1971), the Government of Kerala hereby make the following further amendment to the Kerala Private Forests (Vesting and Assignment) Rules, 1974, issued under notification No. 71470/FS 1/73/AD dated the 23<sup>rd</sup> December, 1974 and published as S.R.O.No.1/75 in Kerala Gazette extraordinary No.4 dated the 2<sup>nd</sup> January, 1975, namely:-

#### AMENDMENT

In the said rules, after rule 2, the following rule shall be inserted, namely:-

"2A. Demarcation of boundaries. (1) Demarcation of private Forests in pursuance of section 6 of the Act shall be effected by erecting cairns along the boundaries.

(2) A Notification specifying the details of the private forest, the boundaries of which have been demarcated such as survey & sub-division No. if available and local name and describing its boundaries shall immediately be published simultaneously in the Village Office, Panchayat Office etc. The Kerala Private Forests (V&A) Rules 1974 have to be amended for this purpose. The Notification is issued to achieve the above purpose.

SRO No. In exercise of the powers conferred by sub-section(5) of the Secretary to Government,7 and Secretary to Government.17 of the Kerala Private Forests (V&A) Act 1971 (26 of 1971), the Government of Kerala hereby make the following further amendment to the KPR Kerala Private Forests (Tribunal) Rules, 1972, issued under Notification No.24367/FS1/71/AD dt. #### AMENDMENT

In the said Rules, in rule 3, for the proviso, the following explanation shall be substituted namely:

"Explanation:- For the purpose of this rule, the date on which the act which gives rise to the dispute was done, shall be the date of publication of the Notification under sub-rule (2) of rule 2A of the Kerala Private Forests (V&A) Rules, 1974, in respect of the land to which the dispute relates".

### (This does not form part of the notification)

Government have amended rule 2 of the Kerala Private Forests (Vesting and Assignment) Rules, 1974 bringing in a new rule as Rule 2A. As per this rule 2A demarcation of Private Forests shall be effected by erecting cairns along the boundaries and a Notification to this effect will be published. Government propose to make it clear that the date on which
