ORDER

The Accountant General has requested certain clarifications in respect of the orders issued in the G.O. read above, Government have examined the points and are pleased in issue the following clarifications:-

- (i) The G.O. read above contemplates only the modification in respect of paragraph 3 (a) of G.O. (P) No. 605/70/Fin. Dated 26th August 1970 and hence paragraph 3 (b) is in continued operation. An officer can therefore, enjoy the benefit of surrender pf earned leave, viz for a maximum period of 30 days under paragraph 3 (a) of the G.O. dated 26th August 1970 as modified in the G.O. read above and for a maximum period of 15 days under paragraph 3 (b) of the G.O. dated 26th August 1970, once in twelve months either independently or in combination, if he is eligible for the benefit of surrender of leave under the respective orders.
- (ii) As the requirement to avail 30 days' earned leave has been dispensed with in the G.O. read above the conditions regarding surrender of earned leave under both the schemes will be the same, i.e. the conditions applicable in respect of surrender of 30 days' earned leave as per the G.O. lead above will be those for the surrender of a maximum of 15 days' earned leave under paragraph 3 (b) of G.O (P)No.605/70/Fin. Dated 26th August 1970. But those who enjoyed the benefit of surrender of earned leave for 30 days under paragraph 3 (a) of G.O.(P) No. 605/70/Fin. Dated 26th August 1970 can surrender 30 days' earned leave only after twelve months from the date of expiry of the period of earned leave to which the previous surrender was related.
