ORDER

The term of the special staff consisting of one Special Deputy Tahsildar, 4 Village Assistants and one Peon sanctioned in the G.O. read as first paper above, for the enumeration of occupations in the Peechi Project and the Game Sanctuary area expired on 28-02-1966.

- 2. The District Collector, Trichur has reported that their continuance is absolutely essential, as a god number of items of work are remaining to be done in that District with the aid of the special staff, such in Trichur Forest Division, demarcation of Forest boundaries in encroachment areas, the eviction scheme for the Peechi Project and Game Sanctuary to be implemented etc.
- 3. The Secretary, Board of Revenue has recommended the proposal of the Collector. Considering the nature of various items of work to be done, the Chief Conservator of Forests has also recommended the proposal.
- 4. In the circumstances, sanction is accorded for the continuance of the above posts of Special Deputy Tahsildar, 4 Village Assistants and one Peon for a period of 6 months from 1-3-1966 subject to the condition that the entire work for which the staff has been appointed will be completed within the extended period and that no further extension will be granted.
- 5. The expenditure will be debited to the provision under "70 (c) iii. C. Survey of Forest Boundaries" during 1966-67.
