ORDER

In pursuance of the discussions recently held with the representatives of various Service Organizations. Government have agreed that with regard to the holidays, Casual Leave and Restricted Holidays, the position existing before the emergency will be restored. In G.O fourth read above, it has been ordered that in future all Second Saturdays will be holidays for the Government Offices. Thus the holidays for Siva Ratri, Vijaya Desami and Deepavali declared as working days in G.O. second read above, are only remaining to be restored as holidays. Government are therefore pleased to order as follows:-

- 1. Siva Ratri, Vijaya Dasami and Deepavali will be holidays for all Government Offices in the State, in future.
- 2. The maximum number of Casual Leave that can be availed of by an employee will be reduced from 18 to 15 days.
- 3. The maximum number of Restricted Holidays that can be availed of by an employee will be increased from the existing number of 2 to 5 out of the Restricted Holidays notified during every year.

4. The reduction of Casual Leave and the increase in the number of Restricted Holidays will however apply only from the year 1978.
