ORDER

Government are pleased to accord sanction to bifurcate the Wildlife Circle, Kottayam into two as specified below:

- 1. The Present Wildlife circle with Head Quarters at Kottayam under the Administrative Control of Field Director, Project Tiger, Kottayam is bifurcated into two Wildlife Circles namely
 - (a). Wildlife Circle, Central Region with Head Quarters at Kottayam.
 - (b). Wildlife Circle, Northern Region with Headquarters at Palakkad.
- 2. Wildlife Circle, Central Region, Kottayam will have administrative control over the following Wildlife divisions with Sanctuaries and National Parks shown against them.

Wildlife Division, Thekkady _ Periyar Tiger Reserve

Wildlife Division, Idukki _ Idukki Wildlife Sanctuary,

Thattekkad Bird Sanctuary, Chinnar Wildlife Sanctuary and Eravikulam National Park.

GRASSLAND AFFORESTATION DIVISION, PEERMADE.

3. Wildlife Circle, Northern Region, Palakkad will have administrative control over the following wildlife divisions with sanctuaries and national parks shown against them.

Wildlife Division, Parambikulam Parambikulam Wildlife Sanctuary

Wildlife Division, Silent Valley Silent Valley National Park.

- 4. Administrative control over proposed Kumarakom Bird Sanctuary will be with Field Director, Project Tiger, Kottayam.
- 5. Administrative control over Shendurney Wildlife Sanctuary will be hereafter with Wildlife Warden, Trivandrum.
- 6. Conservator of Forests, Agasthyavanam Biological Park,
 Thiruvananthapuram will have Administrative Control over Agasthyavanam
 Biological Park, Thiruvananthapuram Wildlife Division and proposed
 Gandhivanam (Smrithivanam), Purakkad, Alappuzha.
- 7. The post of Conservator of Forests (Wildlife) Head Quarters,
 Thiruvananthapuram along with the present incumbent is shifted to Palakkad
 and redesignated as Conservator of Forests (Wildlife) Northern Region,
 Palakkad.
- 8. The post of Administrative Assistant of the Office of Field Director, Project Tiger is shifted to the office of Chief Conservator of Forests (Wildlife), Thiruvananthapuram.
- 9. The post of Senior Superintendent of the Office of the Chief Conservator of Forests (Wildlife) Thiruvananthapuram is shifted to the newly formed office of Conservator of Forests (Wildlife), Northern Region, Palakkad.
- 10. The posts of other ministerial staff in the office of Field Director, Project Tiger are redistributed as follows:
