ORDER

The Government of India have decided to treat the ex-airmen of the Auxiliary Air Force who were called up for Air Force Service under Section 25 (c) of the Reserve and Auxiliary Air Forces Act, 1952 in the present emergency and have been discharged after a continuous engagement of over six months, on a par with discharged Central Government Employees for purposes of appointment through Employment Exchanges, provided they were employed on a whole-time basis against regular establishment for not less than six months. In their letter read above the Government of India have also requested this Government that similar priority may be assigned to such personnel for recruitment through Employment Exchanges to vacancies under the State Government as well. The Government are pleased to direct that the ex-airmen of the Auxiliary Air Force who were called up for Air Force Service under Section 25 (c) of the Reserve and Auxiliary Air Forces Act, 1952 in the present emergency and have been discharged after a continuous engagement of over six months be bracketed with persons who serve on the permanent staff of the Territorial Army for a period of more than six months and on their discharge revert to part-time employment in the Territorial Army and Territorial Army personnel who were embodied in the present emergency and have been disembodied after a continuous engagement of over six months, included under Category II in the order read as second paper above and they order accordingly.

In view of the above order and in view of the order read as fourth paper above priority for purposes of appointment through Employment Exchanges to vacancies under the State will be as follows:

Category No. I. Ex-service personnel of the Defence Forces and discharged State Government Employees-

- (a) Jawans disabled in operations during the present emergency subject to suitability.
- (b) Members of the families of Jawans killed in action or reported to be missing during the present emergency;
 - (c) Wives of Jawans who are trained for teachers' posts.
 - (d) Other released persons of the Defence Services;
- (e) Discharged State Government Employees, displaced Goldsmiths and released N. C. C. Cadet Instructors.
 - (f) Burma repatriates.

Category No. II. Persons who serve on the permanent staff of the Territorial Army for a period of more than six months and, on their discharge revert to part-time employment in the Territorial Army; Territorial Army personnel who were embodied in the present emergency and have been disembodied after a continuous engagement of over six months; an ex-airmen of the Auxiliary Air Force who were called up for Air For Service under Section 25 (c) of the Reserve and Auxiliary Air Forces A 1952 in the present emergency and have been discharged after a continu engagement of over six months.
