### ORDER

Sri. V.B.David, a nominee of the Public Service Commission was appointed as a Forest Guard with effect from 29-04-64 in the Chalakudy Forest Division. He was granted earned leave for 15 days from 1-4-1965. In continuation of the earned leave he was granted 90 days leave without allowances. This leave expired on 15-7-65. He again applied for extension of leave by another 90 days from 15-7-65. As per rule 88 (ii) Part I K.S.R. he was not eligible for leave without allowances for more than 90 days at a time. He should have therefore rejoined duty on that 15-7-65. Since he did not turn up for duty on that date, the Divisional Forest Officer Chalakudy issued orders terminating the service of the guard with effect from 15-4-65.

2. Sri.V.B.David in his petition read as first paper above he has stated that while he was on earned leave from 1-4-65 his aged father fell ill. As the only grown up son he had to look after him for some time and therefore he could not rejoin duty after the earned leave and he had to apply for extension for 90 days more from 16-4-65 and for another 90 days from 16-7-65. He has further stated that he is the only earning member of his family and that he is finding it hard to maintain his family for want of employment. He has therefore requested for reinstatement in service.

3. Government have considered the question carefully and are pleased to order with the concurrence of the Public Service Commission that Sri. V.B.David will be reappointed as Forest Guard subject to the condition that his reappointment will be treated as first appointment to the service by direct recruitment and that he will not be entitled to count any portion of his previous service for any benefit or concession admissible under any rule or order.
