NOTIFICATION

S.R.O No.853/78---In exercise of the powers conferred by subsection(1) of section 2 of the Kerala Public Services Act, 1968 (190f 1968), read with section 3 thereof, the Government of Kerala hereby make the following amendments to the Kerala Service Rules, namely:-

AMENDMENTS (C.S.No. 346/78)

In the said rules, in Appendix VII, in the rules relating to Casual Leave, in rule2-

- (1) in sub-rule (i), --
 - (a) for the word "fifteen", the word "twenty" shall be substituted;
 - (b) the following sentence shall be added at the end, namely:-

"But the members of the teaching staff of educational institutions shall be eligible for casual leave only for fifteen days in a calendar year,"

(2) in sub-rule (ii), for the first sentence the following shall be substituted, namely:---

"All officers including teaching staff of educational institutions may be allowed to combine casual leave with Sundays and other authorized holidays provided that the resulting period of absence from duty shall not exceed fifteen days at a stretch";

(3) in sub rule (iii), for the figure '15', the word "twenty" shall be substituted.

Explanatory Note

In the G.O read as first paper, orders were issued enhance number of casual leave in a calendar year to 20 days. In the letter and 3rd read, the Special representative, New Delhi and the Secretary, Board of Revenue (L.R) have requested to enhance the total period of absence from duty by availing of causal leave with authorized holidays. Government after detailed examination have accepted the suggestion. In the G.O. 4th read above it was clarified that the orders issued in the G.O. read as Ist paper does not apply to teaching staff of the Educational Institutions. This amendment is to give statutory validity to the above decision of Government.
