ORDER

In the G.O. read as Ist paper above it was ordered that the Government of India rates of interest on General Provident Fund (CS) Deposits from time to time would be adopted by the State Government for all types of Provident Funds administered by Government.

In the resolution read as third paper above Government of India have amounced that during the year 1981-82, accumulations at the credit of subscribers to the General Provident Fund and other similar Funds shall carry interest at the rate of 9% per annum upto Rs. 25,000 and at the rate of 8.5% per annum on balance in excess of Rs. 25,000 and that these rates would be in force during the financial year beginning from 1-4-1981. The Accountant General also has requested, vide his letter referred to as 4th paper, above that the State Government may consider revision of the rate of interest on the various Provident Funds administered by them.

In order to encourage larger deposits Government are now pleased to order that the interest at a flat rate of 9% (without any reduction for amounts in excess of Rs. 25,000) will be allowed on all deposits and also on balances at the credit of the subscribers without any financial limit to the following Provident Funds during the Financial year beginning on 1-4-1981.
