

Copy of Office Memorandum No. 31011/12/78-Estt(A). dated the 26<sup>th</sup> December 1978. from the Government of India, Ministry of Home Affairs, Department of Personal & Administration Reforms New Delhi.

Sub:- LTC – Extension of the currency of the LTC admissible for the four year block 1974-77.

The undersigned is directed to say that by this Department O.M.No. 31011/10/78-Estt.(dated the 1st September, 1978, the LTC scheme has been liberalized with effect from 1-9-78, providing for full reimbursement without any deduction in respect of the Direct 400/160 kms, as the case may be, so far as LTC to visit any place in India other than home town.) once in a block of four years is concerned. It has been further clarified in the O.M. of even number dated the 7<sup>th</sup> November, 1978 that the liberalization which is effective from 1-9-1978 will also be applicable to journeys undertaken on or after 1-9-1978 in respect of the block 1974-77, carried over to 1978 Representations have been received by Government to the effect that the available for availing of the liberalized provisions for the block 1974-77 is very short as, in the normal course, the concession in respect of that block has to be avails of on or before 31-12-1978 and it is very difficult to get leave and secure railway reservations within the limit is period available. The representations have been carefully considered and it has been decided that the grace period from availing of the LTC to visit any place in India for the four years block 1974-77 may be extended up to 30-5-79.

2.Ministry of Finance etc. are requested to give the above revision vide publicity and to bring it to the notice of all Government Servants serving under their control.

3.In so far as persons serving in the Indian Audit & Accounts Department are concerned, these orders issue in consultation with the Comptroller & Auditor General.
