ORDER

The General Elections to local bodies are scheduled to be held on 15-9-79 and 18-9-79. For the conduct of election, polling stations have to be set up in various places. Polling stations have to be set up in various places. Polling personnel have to be appointed from among Government Servants and for this purpose a list of Officers and last grade servants working in the various departments will have to be obtained by the Election authorities viz. The District Panchayat Officers in respect of Panchayats and the municipal and Corporation Commissioners in respect of municipalities and corporations.

In the circumstances, Government are pleased to issue the following instructions.

- 1. The Director of Public Instructions Will issue suitable instructions to the Heads of Educational institutions to wherein polling stations are to be located to comply with the requests from the authorities in conduct of elections.
- 2. All Heads of Departments and Offices will forward a list of Officers and last grade servants working under their to the District Panchayat Officers concerned before 31-7-79 Positively to enable the selection of polling personnel sufficiently early. The District Panchayat Officers will make available to the municipal and corporation Commissioners within thier respective jurisdiction a list of officers and last grade servants to be appointed as polling personnel in the municipal and Corporation areas to the extent required by the Commissioners.
- 3. All Heads of Departments and Offices are instructed not to grant leave or transfer the personnel working under them till the election are over, except in unavoidable circumstances.
- 4. All Heads of Departments and Offices are requested to extend their whole hearted co-operation and assistance to the Officers in charge of the conduct of the elections for the successful conduct of the elections
