

## Abstract

Pay and Allowances for December 1981—Early Disbursement in Connection with Christmas—Orders Issued.

## ORDER

In view of the ensuing Christmas Festival, Government are pleased to order in relaxation of Article 75 (b)(i) of the Kerala Financial Code, Volume I that the pay and allowances of all Government officers including full-time and part-time contingent employees, work establishment staff and the N.M.R. Workers of all Departments for the month of December 1981 will be disbursed from the treasuries on the 17th, 18th, 21st, 22nd and 23rd of December 1981 as per the following programme:

- (i) Officers of the Educational Institutions, High Court and Civil Courts (all vacation departments) will be paid their pay and allowances on the 17th and 18th December 1981.
  - (ii) Officers of the departments included in Part A of the schedule under Article 75 (b) (i) of the Kerala Financial Code, Volume I will be paid their pay and allowances on the 21st, those of the departments in Part B of the schedule on the 22nd and those of the departments in Part C on the 23rd December 1981.
- 3. The Departments concerned will present the bills in the treasuries three working days in advance of the day fixed for their encashment as required in Article 76 (b) of the Kerala Financial Code, Volume  $I_{\bullet}$
