O R D E R.

In the circumstances reported by the Chief Conservator of Forests and the Director of Panchayats on the subject, Government are pleased to order that the ferry at Illithode will be auctioned by the Malayattur Neeliaswaram Panchayat on the following conditions only.

1. The right of conducting ferry shall not be awarded to a person who is unacceptable to Forest Department. For this a non-objection statement may be obtained from the Range Officer Kodanad before awarding the contract.

2. a. Sufficient additional security should be taken from the contractor to cover any penalty that might be imposed on him for violation of these rules.

b. A special clause shall be included in his Kychit or agreement as below.

"The Contractor shall be responsible for any illicit fellings or removal of trees or other Forest produce within a radius of one furlong of his ferry. Unless proved otherwise to satisfaction of the Range Officer, Kodanad such illicit felling may render his contract liable to be cancelled in addition to the forfeiture of all money paid by him and he will also be for prosecution and for payment of the value of timber or of forest produce illicitly felled or removed if any as assess the Range Officer Kodanad. The contractor will be liable report any such illicit felling or removal to the Range Officer Kodanad.

c. The amount of fine if any so inflicted shall be credited to the Forest Department by the Panchayat after deducting it from the party.

d. The lease or right shall be made liable if on violation of the clause 2 (b) if so demanded by the Range Officer, Malayattur.

3. He should not make any structures either of a permanent or temporary nature or jetty on the southern side of the river.

4. The foot path to the ferry through the plantation shall not be improved in any way and it will be considered as a right of way only.
