EARNED LEAVE – SURRENDER OF EARNED LEAVE AT THE TIME OF
RETIREMENT –EXTENSION OF BENEFIT TO FULL TIME CONTINGENT
EMPLOYEES – ORDERS ISSUED.

ORDER

In the G.O. read as first paper above, the State Government Employees All India Service Officers borne on the cadre of the state were permitted encash earned leave at their credit at the time of retirement subject to maximum of 120 days provided the leave salary will be reduced by pension and pension equivalent of death-cum-retirement gratuity. Subsequently in the G.O. read as second paper the leave salary for surrender of earned leave was allowed to be paid without deduction of pension and pension equivalent of Death-cum-retirement gratuity to State Government Employees and All India Service Officers borne on the cadre of the State in aspect of surrender of earned leave at the time of retirement.

The G.O. dated 20-12-1975 does not specifically cover Full Time Contingent employees even though these category of employees are eligible for Earned Leave, Half Pay Leave etc., as contemplated under part I, Kerala Service Rules. They have already been allowed the benefit on surrender of earned Leave as sanctioned to other regular Government servants with effect from 13-12-1967 as per G.O.(P) 541/67/Fin. Dated 13-12-1967.

As per employees are governed by Kerala Service Rules in regard to Leave Rules and as they are allowed the benefit of surrender of Earned Leave just like their counterparts in regular Government service, the benefits as contemplated in G.O. dated 20-12-1975 will have to be extended to them, Government are therefore, pleased in order

that this category of employees will be eligible for the benefits contemplated in G.O. (P) 567/75/Fin. Dated 20-12-1975 as modified in G.O.(P) 764/78/Fin. Dated 19-10-1978.

These orders will take effect from the date of issue.
