

Public Services—Departmental Tests—Exemption to those who passed the Madras Fundamental Rules from passing Kerala Service Rules in the Account Test for Executive Officers—Orders issued

## ORDER

In the G. O. read as second paper above it was ordered by Government that the candidates who had already passed Travancore Service Rules and Cochin Service Rules before June 1962 will be exempted from passing Kerala Service Rules in Account Test (Lower) or (Higher) as the case may be and that those who had passed the Madras Fundamental Rules in the Madras Special and Departmental Tests before June 1962 will be exempted from passing Kerala Service Rules in the Account Test (Lower) for all purposes. Earlier in the G. O. read as first paper above it was ordered by Government that the candi dates who have passed the papers of Account Test (Lower) or (Higher) will be exempted from passing the papers on the corresponding subjects in the Account Test for Executive Officers.

2. A point of doubt has since been raised whether the benefit contemplated in the G. O. read as second paper above will be available to Account Test for Executive Officers also. Government therefore in consultation with the Public Service Commission hereby clarify that the benefit contemplated in the G. O. read as second paper above will be available to Account Test for Executive Officers also (ie. those who had passed Travancore Service Rules and Cochin Service Rules or Madras Fundamental Rules in the Madras GPT. 3/4096/MC.

Special and Departmental Tests before June 1962 will be exempted from passing Kerala Service Rules in the Account Test for Executive Officers also).
