O R D E R

In the Government Order read as first paper above, Government issued orders allowing the benefit of a higher grade with effect from 1-7-1979, to all Non-Gazetted Officers who remain in the entry grade for 13 years without a promotion in the normal course. Detailed instructions for the implementation of the above have been issued in the G.O. second cited.

2. In the letter read as 6th paper, the Secretary, Board of Revenue, Trivandrum has requested Government to consider the entire service of Village Assistants who were subsequently promoted/posted as L.D. Clerks for computing the 13 year's qualifying service for granting higher grade. In support of his proposal, the Secretary Board of Revenue has cited the cases of Copyists/Amins/L.D. Typists who were appointed as L.D. Clerks subsequently, in whose case the entire service has been reckoned for the purpose of computing the 13 years' period.

3. Government have examined the question in detail and are pleased to order that in the case of those who were first appointed as Village Assistant and subsequently posted/promoted as L.D. Clerk, the service rendered by them, in the post of Village Assistant will be reckoned for computing the 13 year qualifying service, for the purpose of granting the benefit of grade promotion, in terms of G.O. (P) 1041/79/ (142)/Fin. dated 27-11-1979 as is done in the case of Copyist, Amin and L.D. Typist as per the G.Os referred to as 3rd, 4th and 5th papers above.

4. These orders will take effect from 1-7-1979.
