ORDER

- 1. In the Government Order read as first and fourth papers above Government sanctioned a further higher grade to the last grade employees who have completed 25 years of qualifying service. The orders in this regard have been given effect to from 30-6-1983
- 2. Certain Heads of Department and Offices have sought clarification whether such of the employees who are eligible for the higher grade as on 30-6-1983 on completing of 25 years service can be allowed to elect the higher grade promotion on the dates on which they earn an increment to the lower post or any subsequent date.
- 3. The Government have examined the question in detail. In the of grade promotion allowed based on 13 years service in the entry grade same grade, the right of option to elect any date subsequent to the date on which the beneficiaries complete 13 years service has already been granted as per the G.O. read as 2nd \$ 3rd papers above. In the circumstances Government are pleased to order that those who became eligible for higher, grade promotion in terms of the G.O. read as 1st and 4th paper above, on or after 30-6-1983, based on length of service will be given the right of option to elect any date for the higher grade subsequent to the date on which they complete 25 years of qualifying service. All Heads of Departments/ Appointing authorities shall ensure that option in writing is obtained from the beneficiaries concerned before issuing the orders allowing higher grade in such cases. If no options are tendered by the eligible hands within 3 months from the date of requisition for option made by the competent authority, it it will be presumed that such persons Have opted for the date on which they are eligible for the benefit and the Heads of Departments/Appointing authorities shall issue orders accordingly
