ORDER

Government in the G.O. cited have ordered that employees on higher grades based on length of service, if promoted to cadre posts on higher scales are eligible for refixation of pay under Rule 28A, Part I, Kerala Service Rules on account of change of pay in the service based grade. Now doubts have been raised by some Heads of Departments whether refixation under Rule 28A, Part I, Kerala Service Rules is admissible twice once on higher grade promotion and then on subsequent regular promotion against the same scale of pay.

2. It is clarified that the intention of Government is not to give two fixations in the same scale of pay. For example, a Lower Division Clerk who has been given a fixation under Rule 28A on having been promoted to the higher grade post carrying the scale of Upper Division Clerk will not again be given a fixation on his being promoted as Upper Division Clerk on a regular basis. Neither is he eligible for any refixation. The benefit of the G.O. is admissible only in the case of promotion from a higher grade post to another higher post. Fixations, if any given erroneously will be reviewed immediately and excess drawn will be recovered.
