**ORDER**

In the Government Order read as first above orders were issued revising the scales of pay and allowances of the State employees.

2. As the revised scale of pay have taken effect from 1-7-1983, the Accountant General (A & E), Kerala in his letter read as second paper above, have requested Government to intimate whether recovery towards pension contributions and leave salary contributions are to be effected from 1-7-1983 or from 1-4-1985 ie. The data from which payment of salary as per the revised scales of pay is effected.

3. Government have examined the matter in detail. Though the payment of arrears arising out of the pay revision ordered in the Government Order read as first paper above are to be paid only from 1-4-1985, the revision of scales of pay to the various posts has been given effect to from 1-7-1983. Hence the pay of all employees are to be revised and refixed either from 1-7-1983 or from the date on which each employee opts to come over to the revised scale of pay. The rate of leave salary as well as the liability in pensionary claims is directly related to the amount of pay of the employee concerned and any increase in the pay of employee results in enhancement of leave salary and pensionary benefits. In the circumstances Government order that recovery of pension contribution and leave salary at the revised rates will be made from the date of fixation of pay of the employees concerned in the revised scale. Foreign employers will arrange the remittance at the revised rate in this regard from 1-7-1983 or from the date of fixation of pay of the employee in the revised scale as the case may be.
