ORDER

In the Government Order read as 1st paper above, orders were issued revising the scales of pay of State Government employees, merging D.A. and Adhoc D.A. at 488 points in the All India Consumer Price Index-i.e.the rates of Dearness Allowance sanctioned for the increase in the cost of living index above 488 points were allowed as the new Dearness Allowances on the revised scales from 1-4-1985 vide Annexure V of the said Government Order.

- 2. Subsequently it was noticed that in the case of employees in receipt of special pay, there was drop in their dearness allowances, when they came over to the revised scales. This drop was due to the non-reckoning of dearness allowance at488 points on the special pay drawn along with the pre-revision pay, while computing the 'emoluments' in the revised scales. Accordingly in the Government Order second cited, Government ordered that those employees who were in receipt of special pay prior to their coming over to the revised scales of pay pay as on 1-4-1985 and dearness allowances at 488 points plus revised dearness allowance applicable to both pay in the revised scale and special pay on that date, so long as they continue in the post to which special pay is attached. Later on, in the Government Order third cited, the above benefit was extended to those employees who were appointed to posts carrying special pay during the period from 1-4-1985 to 16-9-1985and also to those for whom special pay was newly granted during the above period and Dearness allowances drawn at the pre-revision rates on the basis of pre revision pay plus special pay.
- 3. Now, it has come to the notice of the Government that certain employees who have actually drawn pay in the pre-revision scales and special pay even after 16-9-1985 also sustain drop in dearness allowances, when they get

emoluments in the revised scale, i.e. revised pay, special pay and revised Dearness Allowances. This drop in emoluments is also due to the very same reason explained in Para 2 above. As such Government pleased to order that the benefit contemplated in the Government Orders read as second and third papers above, will be extended to the above categories of employees also, subject to the same conditions laid down in those

Government Orders.
