## **ORDER**

In the G.O. read as first paper above orders were issued revising the scales of pay of State employees on the basis of the recommendations of the Fourth Keralal Pay Commission. In the G.O. read as second paper above orders were issued granting another chance of re-option to those teachers who were granted grade promotions prior to 1-7-1983, subject to the conditions specified therein. These orders were issued to rectify the anomaly that in certain cases of grade promotions of teachers ordered prior to 1-7-1983, the seniors were getting less pay compared to their juniors who got grade promotions after 1-7-1983.

- 2. The General Secretary, Kerala N.G.O.Union has represented that the anomaly mentioned above exists in the case of other Government employees also. He has, therefore, requested to extend the benefit of re-options allowed to teachers, to other employees who got grade promotion before 1-7-1983.
- 3. Government have examined the case in detail are pleased to extend the benefit of re-option sanctioned in G.O. (P) 526/86/(85)/Fin. Dated 2-8-1986 to employees other than teachers, who got service based grade promotion cadre promotion before 1-7-1983 for postponement of such promotions to any date on or after 1-7-1983 subject to the conditions that excess pay drawn should be refunded in lump and that the re-option should be exercised with in a period of three months from the date of this order.
