**S.R.O.No. 799/87**---- In exercise of the powers conferred by sub-section (i) of section 2 of the Kerala Public Services Act, 1968 (19 of 1968), read with section 3 thereof, the Government of Kerala hereby make the following rules further to amend the Kerala Service Rules, namely:---

#### **RULES**

### C.S.No. 451/87

- 1. Short title and commencement. ----
  - (i) These Rules may be called the Kerala Service (Amendment) Rules, 1987.
  - (ii) They shall come into force at once.
- 2. Amendment of the Rules.—In Part I of the Kerala Service Rules, the proviso to rule 84 shall be omitted

# **Explanatory Note**

(This does not form part of the Notification but is intended to indicate its general purport.)

According to the proviso to Rule 84 Part I, Kerala Service Rules Committed Leave can be granted only if the authority competent to sanction the leave has reason to believe that the officer will rejoin duty on expiry of the leave. So, just to satisfy the requirement of the above rule officers on Commuted Leave should necessarily rejoin duty on the last or but one or two days prior to their retirement. This rejoining duty creates much administrative inconvenience and unavoidable paper work.

This amendment is intended to take away the above proviso so that officers who desire to go on Commuted Leave preparatory to retirement can do so.
