ORDER

- 1. By the G.O. read first, Government issued revised guidelines of the grant of leave without Allowances to Government Officers to take up employment abroad or within the country. These guidelines have been incorporated in the Kerala Service Rules as Appendix XIIA wide the G.O. read second. According to these rules the maximum period of leave that may be sanctioned to an officer during the entire service is 10 years.
- 2. Government have received representations from the Association of Kerala Employees on Leave Working Abroad to raise the maximum period of leave to 15 years.
- 3. Government have examined the request in detail and are pleased to raise the maximum period of leave that may be sanctioned to an officer for the purpose of taking up employment abroad or within the country during his entire service to fifteen years subject to the following conditions:-
 - (i) Even in the case of those who have gone on leave prior to 16-12-1983, the conditions laid down in Appendix XIIA, K.S.R. will apply.
 - (ii) While granting extension beyond 10 years an undertaking will be obtained from the officer to the effect that he agrees to abide by the conditions laid down in Appendix XIIA.K.S.R.

- 4. Cases of those who have already left service will not be re-opened.
- 5. Necessary amendment to Appendix XIIA.K.S.R. will be issued separately.
