ORDER

In the G.O. read as first paper above, orders were issued revising the pay allowance of State Government Employees. Under the foot-note relating to Last Grade Employees, occurring on page 5 of the G.O. read as first paper above, it was indicated that "the existing ratio of 1:9 between Grade II and Grade I of the Last Grade Employees will be revised to 1:5". The intention of Government in this regard was to revise the existing ratio of 1:9 between Grade I and Grade II Last Grade Employees as 1:5. Hence the foot- note mentioned above requires correction.

2. In order to rectify the mistake, Government order that the first sentence relating to the revision of the ratio of the Last Grade Employees in the foot,.-note on page 5 of Annexure II of the G.O. dated 16-9-1985 will be corrected and read as follows:

"The existing ratio of 1:9 between Grade I and Grade II of Last Grade Employees will be revised as 1:5".

3. This order will have effect from 16-9-1985.
